NOTICE INVITING QUOTATION

(a) Quotation for supply of Identity Cards for session 2026-2027 .

1. Sealed Quotation for the supply of identity cards for staff and students is invited by the undersigned on behalf of the Manager ,DAV Public Sr. Sec. School ,Bina Project ,Sonbhadra (U.P) up to 03:00 p.m by 29.04.2026.

Quotations should be sent under sealed cover marked as:

Quotation for " Supply of Identity Cards " and not by name .Quotations will be opened in the office of the undersigned at 01:30 p.m on 30.04.2026 (Thursday).

2. The quotations shall be submitted according to the terms and conditions specified in paragraph 3 to 13.Unless specified otherwise in the quotations ,it shall be construed that the terms and conditions stipulated hereunder have been agreed to.

3. The rates should be F.O.R and should include excise duty ,sales tax , freight charges ,any other taxes ,rates or impositions which are leviable e.g packing charges in respect of the supplies. The School /Institution shall not be liable to pay any tax ,freight etc which has not been expressly stipulated in the quotation in the event of acceptance of the quotation.

4. There should not be any overwriting or corrections in the quotation. If a figure is to be amended , it should be neatly scored out ,the revised figure written above and the same attested with full signature and date. In the absence of such attestation the quotation is liable to be rejected.

5. The undersigned does not bind himself to accept the lowest quotation and reserves the right to accept the quotation in whole or in part i.e with respect to all the articles mentioned in the attached statement or in respect of one or more than one articles specified in the attached statement as he may decide.

6. On acceptance of the quotation it will become a contract and the contractor shall be bound by the terms and conditions of the quotation.

7. If the contractor fails to supply the articles within the time stipulated in the letter of acceptance by the undersigned ,the undersigned shall be at liberty to purchase the articles from the market or get the rest of the contract completed by any other person or firm and the difference of price ,if any ,shall be

deducted from the earnest money /security Deposit (if any) and in case any amount in excess of the security deposit is paid by the undersigned ,the contractor shall be liable to pay this amount.

8. The quantity of the articles indicated in the attached statement may be increased or decreased at the discretion of the undersigned without assigning any reason.
9. Prior to acceptance of quotation ,the undersigned reserves the right to call for samples or demonstration and the contractor shall be liable to supply the samples or give the demonstration free of cost.
10. In the event of acceptance of quotation and placing of the order for work/ purchase ,the article ordered for would be subjected to an inspection by the undersigned or my representative and are liable to be rejected if the articles supplied are not according to approved samples or do not conform to the specifications prescribed.
11. The rates quoted by the contractor shall hold good up to six months. No amendment in the rate except increase in the rate of Sales Tax during the period of execution of the contract will be accepted.
12. The amount of Security Deposit(if any) shall be retained by the School /Institution for a period of six months from the date of completion of supplies as a safeguard against any defect appearing in the articles supplied within this period.
13. Quotations which do not comply with the above conditions are liable to be rejected .
